 - o Bowman was acquired by Mediware, and then TPG Capital last year; so far, no changes.
 - o April 3rd, Bowman will release new reports for the Sage APR repository

 - Old ART APR reports will be available for 3-4 months to come
 - New data quality reports will also be released April 3rd
 - Qlik Sense, a new reporting tool replacing ART, will be released April 10th. Governance Committee has approved funding for in-person training in North Carolina.
- MCAH Update
 - New menu for online training
 - Includes more trainings than NCCEH requires for new users, or Agency Admins
 - HUD Data Standards training was out-of-date and <u>NCCEH</u> has created a replacement
